The Nomination Forms can be obtained free of cost from the office of the society on date and time mentioned above. Nomination forms should be handed over to the undersigned by the candidate personally or by his/ her proposer or seconder on the date and time mentioned above together with the cash security of Rs. 2,000/- (Rs. Two Thousand Only). In case the contesting candidate gets less than 1/6th of the total votes polled, the security deposit shall be forfeited and such candidate shall be disqualified from contesting the election in that society for a period of 3 terms. No person shall be eligible to contest election on two seats simultaneously. The proposer and seconder shall not be a defaulter (whether loan pending/Guarantee to defaulted Borrower), A member shall not be eligible to contest for the election if he has not completed minimum period of one year from the date of acquiring membership in the Society to the date of filing of the nomination.

The list of members along with the list of defaulter members of the aforesaid society shall be displayed at the office of the undersigned and the notice board of the society for information of the members. Interested members can obtain the membership list from the Society's office against payment of prescribed fees Rs.1,000/- (Rupees One Thousand Only) as per provision of D.C.S. Rules, 2007 (as amended from time to time).

Special Note:

The meeting shall start on 25/11/2018 at 10:00 A:M at Aggarwal Bhawan, Maharaja Agarsen Marg, Shakarpur, Delhi- 110092. and the quorum is not completed the meeting shall stand adjourned for 30 minutes on the same day i.e. up to 10.30 AM.

The adjourned meeting shall take place at the same place to conduct the election of the managing committee of the aforesaid society. In the adjourned meeting no quorum shall be necessary. Immediately after the polling is over the result will be declared after counting on the same day.

Note:

1. As per provisions of DCS Act and Rules, the defaulter members are not eligible to contest the elections, but they are entitled to cast their votes except those members against whom decree has been issued under Section 71. However, in case, if they make the payment of their amount in default before the date of filing of nomination to the society and produce the proof thereof before the Election Officer, they will not be treated as defaulters and shall be allowed to contest election.
2. All the members are requested to bring the proof of their identification by way of ID Proof of the Society, Driving Licence, Identity Card issued by the Election Commission of India or any other documents related for their identification to facilitate the smooth conduct of election
